- Teams can check in from 7-10:00 a.m.
- Competition is not sponsored by KCBS, however, KCBS rules will apply.

- Each team will be provided with 1/2 pound of ground beef.

1. Registration includes cook site (20' x 30'). Sites assigned on a first-come basis.
2. Water available on grounds.
3. Set-up 7:00 a.m. - 10:00 a.m. No check-ins after 10:00 a.m.
4. Cooks' meeting 10:00.
5. No cooking or seasoning meat before inspection.
6. Only charcoal, wood or pellet cookers allowed.
7. Turn-in containers will be provided.
8. Turn-in 5 minutes before until 5 minutes after turn-in times - NO EXCEPTIONS!
9. Judging will be based on appearance, taste and tenderness. Six samples required per entry.
10. Garnish per KCBS rules.
11. Prizes will be given to the first two places in each category and an over-all Grand Champion.
12. Grand Champion will be determined by the best cumulative score of chicken and ribs.
13. Prizes will be awarded as soon as possible after last turn-in.
